The SS4A program funds regional, local, and Tribal initiatives, preventing roadway deaths and serious injuries through the Safe System Approach.

New Transportation Initiative Active for Sturgis

South Dakota • FY23 • Planning Grant • SS4A

Award: \$160,000 - Sturgis is mapping crash hotspots and collecting community feedback to create safer roads, sidewalks, and safety measures for drivers, pedestrians, and all roadway users.



Blue Ash City Leaders Plan to Improve Road, Street Safety

Ohio • FY23 • Planning Grant • SS4A Award: \$120,000

- Blue Ash is creating a survey for residents to share feedback on the city's roads. City leaders emphasized the importance of community feedback in shaping infrastructure decisions.

Decatur Reduces Speed Limits on Major Roads to Improve Pedestrian Safety

Georgia • FY22 • Planning Grant • SS4A Award: \$200,000 -

Decatur is partnering with the Georgia DOT to set speed limits on several corridors. The effort, identified through the city's SS4A Action Plan, targets high-risk areas for pedestrians and cyclists. Updated signage and technology will support the new speed limits, improving safety and reducing the severity of crashes for everyone who travels through these busy streets.
